Information about the speakers

Joseph Kibugu, Business and Human Rights Resource Centre Kenya

Joseph Kibugu is a business and human rights expert, currently serving as the Africa Regional Manager at the Business and Human Rights Resource Centre. He has vast experience supporting actors including civil society organisations, governments and businesses to put human rights at the centre of business operations and prevent abuse. He has conducted field work in the Kenya, Uganda, Tanzania, Malawi, Zambia, Zimbabwe and DRC, including in mining, renewable energy, agribusiness and waste value chains. He has an LLM on international human rights law for the University of Notre Dame, USA. He recently earned his doctorate that focused on the human rights aspects of agribusinesses, from the University of the Witwatersrand, SA.

Maggie Opondo, University of Nairobi

Maggie Opondo has an academic background in feminist geography and climate change vulnerability and adaptation. She has a wealth of experience in ethical trade, business and human rights, climate change, sustainability and gender safeguarding. She is passionate about creating awareness on ethical trade and business and human rights on African global value chains and continues to make a significant impact in advocating for and driving implementation of ethical trade practices, social and climate sustainability in the private sector in collaboration with governments and development organisations. She has been instrumental in mainstreaming and integrating gender into global value chains and climate projects and programs. She has contributed to a body of knowledge on: ethical trade; corporate social responsibility; gender and human rights in global value chains; gendered impacts of climate change on poverty reduction and livelihoods. She has vast experience with mainstreaming and integrating gender into global value chains and climate change projects. She was part of the team of the Ethical Trade Initiative (ETI) Smallholder Group that developed the ETI Smallholder Guidelines (2005) and later the ETI Supervisor Trainer Manual (2008). She was a Coordinating Lead Author, IPCC Chapter 13 (Livelihoods and Poverty), of the Working Group II contribution to the Inter-governmental Panel on Climate Change (IPCC) 5th Assessment Report (AR5) (2010-2014).

Blandina Bobson, Oxfam Kenya

Blandina Ijecha Bobson is the Director of Programmes for Oxfam in Kenya heading the Women's Rights and Gender Justice, Governance and Accountability and Natural Resources Programmes. She has over 15 years' experience leading the conceptualization, design, resource mobilization, implementation, Monitoring and Evaluation of both development and humanitarian programmes within the Africa region. She's a Safeguarding Focal Person and a trained Safeguarding Investigator Blandina is a Women's Rights Champion and is passionate about Women Empowerment. Her passion for fighting for women's rights is driven by her own lived experiences as a girl and a woman from a marginalized and minority community in Kenya. She works towards amplifying the voices of women through research, writing thought pieces and challenging both formal and informal patriarchal systems that





propagate gender inequalities and prevent women and girls from enjoying their rights and achieving their full potential in life.

Blandina holds a Bachelor of Arts Degree in Sociology, Bachelor of Arts Degree in Sustainable Human Development; and currently pursuing a Master's in Humanitarian Aid and International Relations. She is a certified Monitoring and Evaluation practitioner and a Global Public Voices Fellow at Cornell University where she focused on advocacy on inequalities and social injustices.

Stella Wangechi, Kakuzi PLC

Stella Wangechi is a Human Rights Lawyer with over 12 years of diverse experiences in the context of Business and Human Rights, Gender and Access to remedy.

In her previous role as a Senior Human Rights Officer at the Kenyan NHRI, she led the development of the Kenyan National Action Plan on Business and Human Rights. Stella holds a Masters of Laws degree in Sustainable International Development from the University of Washington and a Bachelor of Laws degree. She is a certified mediator and currently leads Tier 1 of the Kakuzi OGM.

Stella is passionate about Human Rights and her goal is to excel as an advocate for social justice.

Violet Mavisi, Head of the Independent Human Rights Mechanism (OGM)

Ms Mavisi is a lawyer of over thirty years with experience in civil and criminal assignments. She holds a law degree from the University of Nairobi and a Masters of Arts degree in Governance and Development from the University of Sussex. She is also a Chevening Fellow. She has worked in the public service as a prosecutor with the Attorney General's Chambers, as the First Vice-Chair and Commissioner with the Kenya National Commission on Human Rights and as a Presiding Judge with the Interim Independent Constitutional Court. She has also worked in the private sector as an advocate and also in the Non-governmental sector. Mavisi is also a Certified Mediator.

Mavisi is currently an Independent consultant in the area of Human Rights, Governance, Gender and Health. Mavisi is currently the Head of the Independent Human Rights Mechanism (OGM) for Kakuzi PLC. Mavisi has consulted for the public service and several governmental and Non-governmental organizations like the National Gender and Equality Commission, The Kenya Judiciary, International Development Law Organization, The Attorney General/Department of Justice, The National Police Service, The United Nations Office on Drugs and Crime, UNDP, FIDA (K), The International Commission of Jurist (K) Chapter and KELIN. Mavisi has also consulted IDLO Somali and UNODC Somaliland thus, developing competencies in legal research, legal drafting, governance, gender, health, project cycle management and process consulting evaluations, election-related work, capacity strengthening and training and facilitation of meetings both locally and internationally.
